This includes advocating for legal and financial conditions that protect institutional diversity and enable long-term strategic planning. I will also support the development of shared tools and guidance to help members navigate tensions between openness, security, and academic independence.

4. Addressing Dual-Use and Security Research with Responsibility and Strategic ForesightIn an increasingly fragmented geopolitical landscape, universities of science and technology face growing pressure to engage in research with potential dual-use applications - technologies that can serve both civilian and military purposes. This includes fields such as artificial intelligence, quantum computing, cybersecurity, and advanced materials. These areas are not only critical for societal resilience and competitiveness, but also for strengthening Europe's strategic autonomy and defense capabilities in a rapidly evolving global security environment.

At **TU Wien**, we have already established dedicated working groups on **research security** and **research integrity and ethics**, which play an active role in our academic governance and daily operations. These structures ensure that sensitive research is conducted responsibly, transparently, and in line with both national and European frameworks. They also foster a culture of critical reflection and institutional learning, which I believe is essential for all **CESAER** members.

As the largest technical university in military **neutral Austria**, **TU Wien** carries a particular responsibility to engage in these debates with care, clarity, and commitment to European values. Our neutrality does not exempt us from contributing to Europe's resilience - it challenges us to do so with even greater emphasis on transparency, ethics, and dialogue.

As Director, I will ensure that **CESAER** provides a trusted and neutral platform for its members to navigate these challenges collectively. This includes:

- Developing shared principles and guidance for responsible dual-use research, aligned with academic freedom and institutional autonomy.
- Facilitating peer exchange on best practices in risk assessment, export control compliance, and ethical review processes.
- Engaging with European institutions to shape coherent policies that support innovation while safeguarding democratic values and human rights.
- Promoting transparency and trust in science by fostering open dialogue with society about the benefits and risks of emerging technologies.
- Supporting the contribution of the technical universities to Europe's defensive preparedness, while
 ensuring that research remains grounded in ethical responsibility and long-term societal benefit.

CESAER must lead in helping its members balance openness with responsibility, and innovation with integrity. By doing so, we can ensure that science and technology remain forces for good—even in the most sensitive domains. I also want to highlight my commitment to head a task force on dual use, defense and space research, independently from my application to the board of directors.
